Speaker Dr Felicity Veal BPharm MSc PhD The Pharmacological Management of Pain

Dr Veal graduated with a Bachelor of Pharmacy at the University of Tasmania in 2007. After completing her intern year in community pharmacy, she worked as the Pharmacist in Charge in a community pharmacy.

She completed a Master of Science in Global Health and Public Policy at the University of Edinburgh, Scotland in 2010 after which she commenced work with the Department of Health and Ageing in the Pharmaceutical Evaluation Section undertaking drug utilization evaluations of medications.

Dr Veal commenced teaching in the School of Pharmacy and Pharmacology at the University of Tasmania in 2013 as Lecturer in Pharmacy Practice and Academic Placement Co-Ordinator.

Dr Veal completed her PhD in 2016 evaluating the pharmacological management of pain in older Australians. Dr Veal's primary research interest is the management of pain, including the use of opioids, identifying factors that affect the transition from acute pain to chronic pain after surgery and pain in aged care facilities.

Current research projects include opioid stewardship programs; management of post-operative pain and the progression to persistent post-operative pain; the provision of pain management advice to surgical patients; the management of pain in residents of aged care facilities and the pharmacokinetics of paracetamol.
